# **Annual Action Plan – Execution, Monitoring, Reporting, etc.**



#### **Manner of Execution and Modalities of Utilization**

- Proposed projects/activities will be implemented by GMR Varalakshmi Foundation, CSR arm of GMR Group.
- GMRVF Team deployed in CSR unit of GHIAL will execute the projects/ activities.
- The entire budget proposed will be utilized through GMRVF only.

#### **Monitoring and reporting mechanism**

- GHIAL CSR committee will meet twice in a year to monitor and review the progress of CSR Projects in terms of both outcome assessments and financial monitoring.
- GHIAL CSR unit will periodically report the progress of CSR projects/activities to the CSR committee and to the management of GHIAL (including monthly reports of activities)
